## Public Participation:

Mr. Kemp stated that there will be a meeting on Friday at South Elementary with Mrs. Wentworth, Mrs. Hall, and Mrs. Triplett to address this issue. Mr. Brand stated we are not getting rid of recess. Mr. Kemp stated that he will get back with her.

Frieda Martin addressed the Board in support of Carl McCrory asking for an extension of his contract.

Jill Rippeth addressed the Board about being notified of Special or Emergency Board Meeting dates. The language is part of the negotiated contract. She is upset about not getting the meeting notice in advance. She would like the courtesy of the agenda the same day and time that the Board receives the agenda. She also is in support of Carl McCrory. Barry Zehnder added that in June they were not notified in a timely manner. Mrs. Erwin apologized taking full responsibility. It was not posted in the NPEA and OAPSE folders in a timely manner which was an oversight.

Jill Westbrook asked about the York Elementary principal position. Is Ms. Smolinski still in the building or is she removed with pay? Mr. Brand stated that Ms. Smolinski is not in the District. The investigation is still on going. She is on leave with pay. Mr. Brand also stated that he is serving as Principal until the investigation is complete.

Amy Welch asked if Mr. Brand was receiving a stipend for serving as Principal. Mr. Kemp stated that he is not.
